Hans-Jörg Schlierer

“SDGs Inside” is a tool which aims the incorporation of sustainability and CSR competencies in different pedagogical programs at EM Lyon Business School. This approach allows a particular program to evaluate the CSR/Sustainability scope and the learning path of a “classical” student. The “Act for Climate” course addresses the “So what?” question by targeting concrete actions to deal with the challenges of climate change.

Arno Kouroula

Amsterdam Business School’s Honours Programme Sustainability selects 25 top students to become systems thinkers and change makers. It includes two student-led interactive courses with collaborations with science-based startups, several visiting speakers, site visits and climate simulations; and two collaborative projects with leading sustainable organizations and Indonesian partner universities. The course is taught simultaneously at 10 business schools including Rotterdam School of Management across Europe and culminates in a large-scale role-play event of a United Nations Framework Convention on Climate Change Conference (UNFCCC) of the parties. The session will provide a window into how role-play works, and other important facets of how the course operates.
